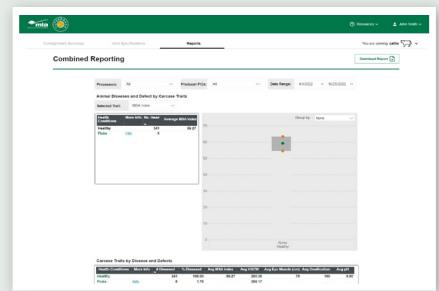
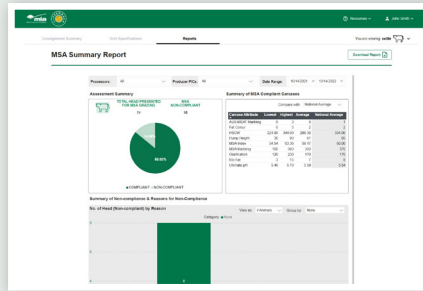
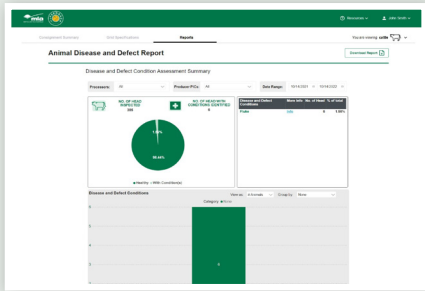
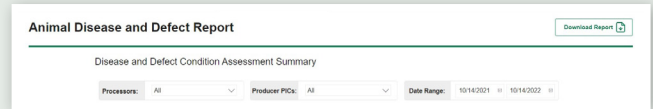


The date range on each report can be changed, and reports can be filtered by selecting from drop-down menus.

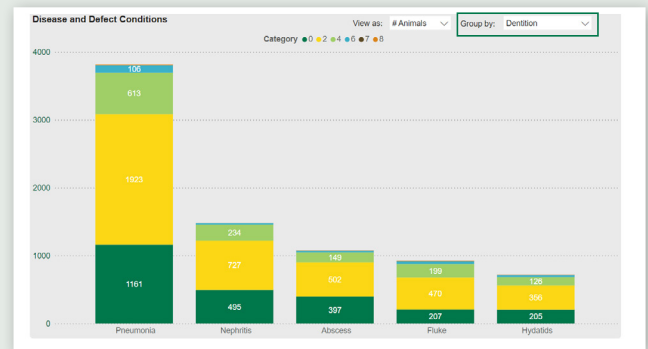
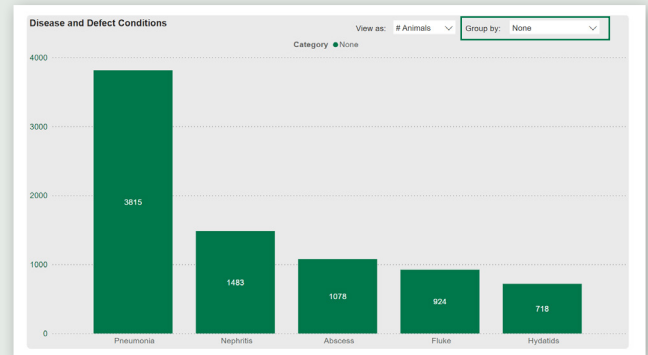
1 Disease and Defect Condition Assessments Summary

The number of head presented in the pie chart depicts the individual animals which have one or more disease or defect conditions.

The number in the conditions table explains the number of individual animals by disease or defect condition. An animal with multiple conditions may be represented multiple times in the count.

Filter by processor, PIC and dates.

Group the report in the cattle section by dentition, feed type, HGP status, MFV, number of days on feed, ossification or sex.



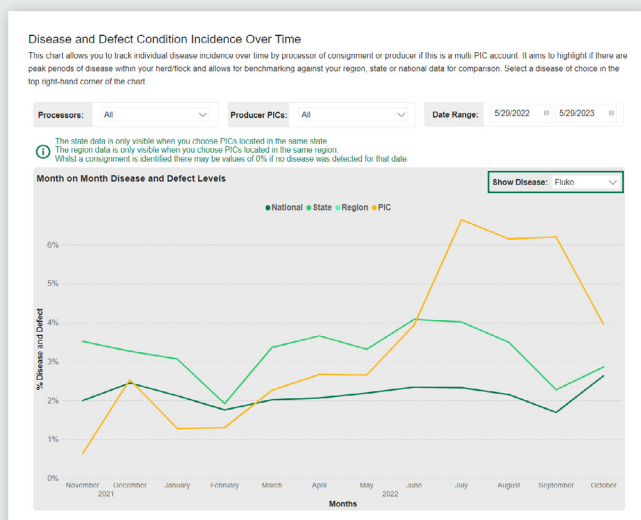

2 Disease and Defect Condition Incidence Over Time

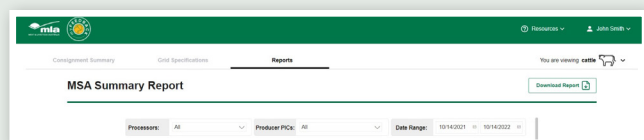
This chart tracks individual disease incidence over time by processor or producer if this is a multi-PIC account. Individual PIC results are shown in orange ●, with comparisons against national ● state ● and regional ● benchmarks.



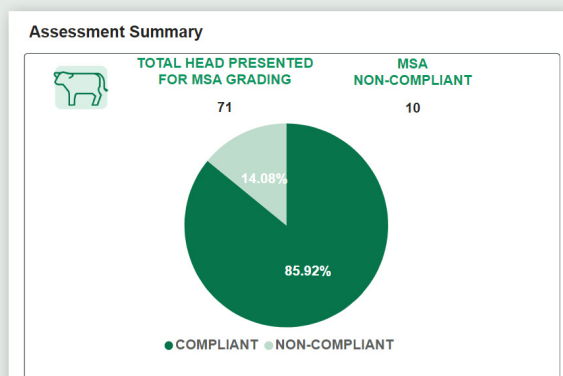
MSA Summary (cattle only)

2 **Assessment Summary:** Provides an overview of livestock presented for MSA grading, with a percentage of those compliant or non-compliant.



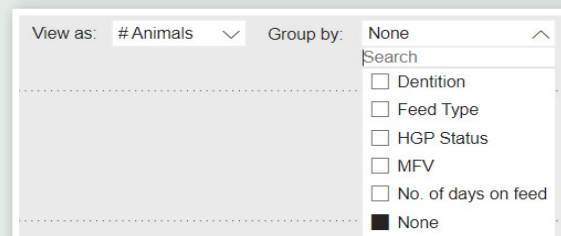

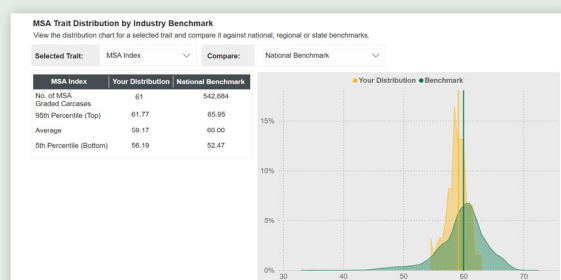

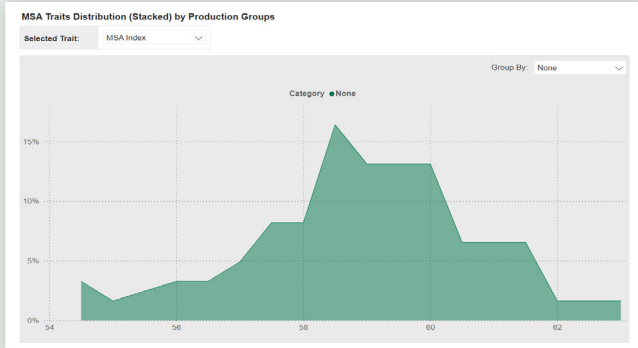


5 **MSA Trait Distribution by Industry Benchmark:** Select to compare an individual trait such as MSA Index (default option), AUS-MEAT marbling, fat colour, HSCW, hump height, MSA marbling, ossification, rib fat or ultimate pH to the national, state or regional benchmark. Select the options from the drop-down menus and the graph will update accordingly.



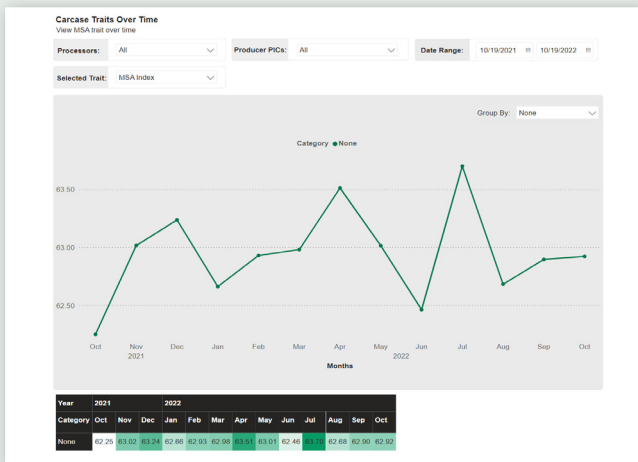
6 MSA Traits Distribution by Production Groups:

View a Selected Trait, such as MSA Index (default option), AUS-MEAT marbling, fat colour, HSCW, hump height, MSA marbling, ossification, rib fat or ultimate pH, stacked by production group. Filter by dentition, feed type, HGP status, MFV, days on feed, ossification or sex.



7 Carcase Traits Over Time:

Filter Selected Trait, such as MSA Index, across date range. Select the 'Trait' and the 'From' and 'To' dates from the drop-down menus and the graph will update accordingly. A further filtering option is available on the graph – select 'Group by' and select trait. The table will provide light or dark colours to highlight peak periods.



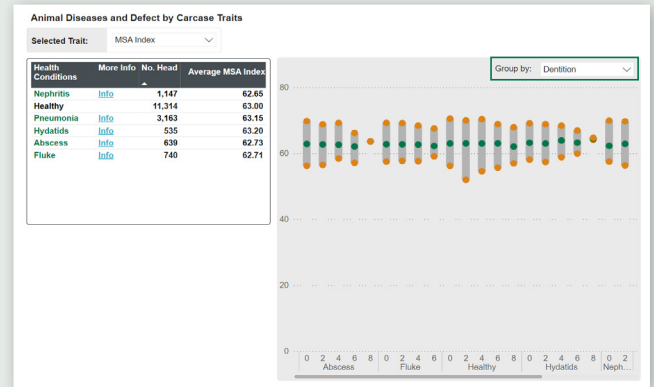
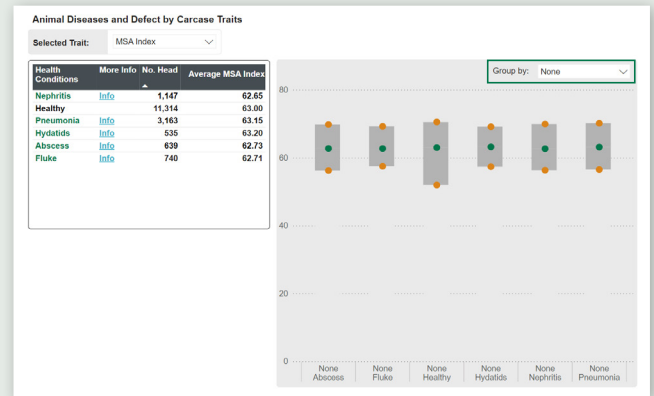
Combined Reporting (cattle only)

1 Animal Diseases and Defect by Carcase Traits:

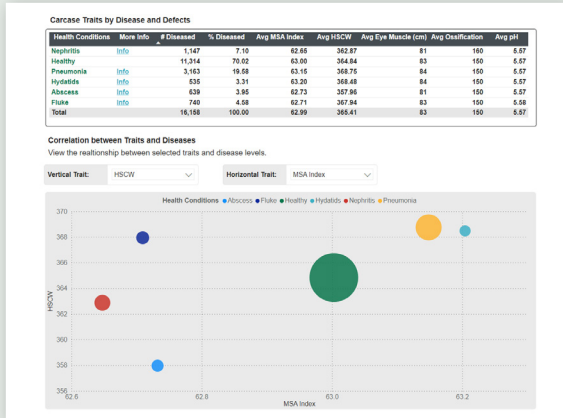
Compare diseased animals against healthy animals. Choose the trait and the chart will update accordingly. Further filter by grouping by gender, dentition or ossification.



In some instances disease animals may appear 'more favourable' for specific traits. MLA Group holds no responsibility for the accuracy of this data as in some instances diseased animals may show signs of disease in offal which may have been from past exposure and not a current illness. Singular, or low number value entire may also skew results.

Carcase Traits by Disease and Defects and Correlation between Traits and Diseases: The table shows disease by number, percentage and average trait to further expand on the box plots above. The correlation chart allows you to view the relationship between traits and disease. Select the 'Vertical trait' and 'Horizontal Trait', from the drop-down menus. The chart will update automatically.

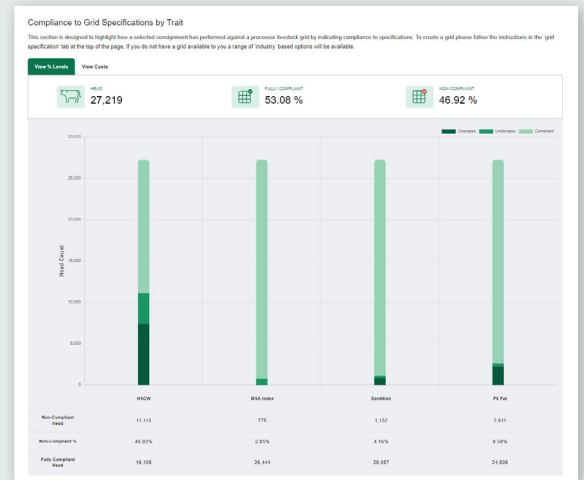

Compliance to Grid Specifications by Trait:

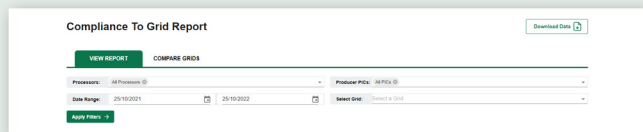
Changing the filters at the top of this report will change the values shown.

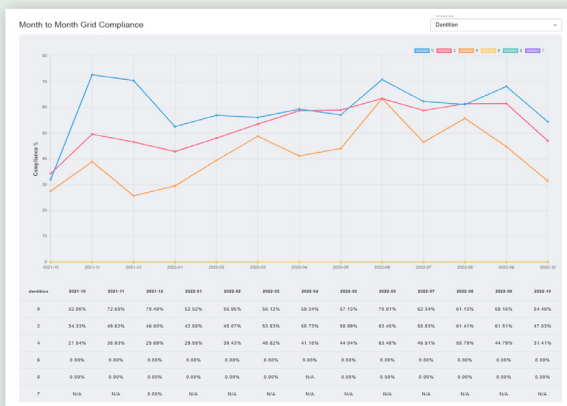
Compare your individual livestock against an individual grid. Filters at the top of the report enable you to select to view data filtered by processor, PIC and date range.

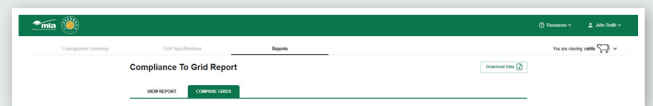
